RESOLVED, That, the following Resolution 77-14, pertaining to an Honor Flight donation, be adopted:

WHEREAS, an average of 800 veterans from WW II are dying per day, many whom never have visited the Washington, D.C. monuments that honor their service and sacrifice; and

WHEREAS, a minimum donation request of \$100.00 was received from Bucks County Recorder of Deeds, Joseph Szafran to contribute to an organization called Honor Flight which is a 501.c.3 organization recognized for transporting veterans to "their" monuments.

NOW, THEREFORE, BE IT RESOLVED, That, the Council of the Borough of Quakertown grants the request of Joseph Szafran to make a \$100.00 contribution to the organization called Honor Flight to aid in transportation costs for Bucks County veterans to visit Washington, D.C.

WHEREAS, continued work on the barn building facility is desirous including renovations to the museum area and the Upper Bucks Chamber of Commerce Office.

NOW, THEREFORE, BE IT RESOLVED, That, the Borough Council of the Borough of Quakertown grants the request to continue the work on the Historical Society barn facility.

NOW, BE IT FURTHER RESOLVED, That, the renovations must go through the permit issuance process even though Council authorizes waiving the permit fee, which does not include plan review or other miscellaneous costs.

RESOLVED, That, the following Resolution 79-14, pertaining to funding for renovations at the Historical Society barn facility, be adopted:

RESOLUTION 79-14

WHEREAS, continued work on the Historical Society barn building facility is desirous including renovations to the museum area and the Upper Bucks Chamber of Commerce Office; and

WHEREAS, a quotation has been received for renovations from Lewis Brothers, Quakertown, Pennsylvania dated April 18, 2014 in the total amount of \$66,438.00; and WHEREAS, the 2014 Quakertown Borough budget has allotted \$40,000.00 for this renovation with the remaining balance to be funded by the Historical Society from other means such as donations, a grant opportunity or low interest loan.

NOW, THEREFORE, BE IT RESOLVED, That, the Borough Council of the Borough of Quakertown authorizes funding in the amount of \$40,000.00 for the Historical Society barn renovations.

Motion of Councilman Rosenberger, seconded by Councilman Erwin. A roll call vote was taken and the motion was unanimously carried.

RESOLVED, That, the following Resolution 80-14, pertaining to an application for a Transportation & Community Development Initiative Grant (TCDI), be adopted:

RESOLUTION 80-14

WHEREAS, the Economic Development Consultant ("Applicant") for the Borough of Quakertown desires to receive from the Delaware Valley Regional Planning Commission a Transportation & Community Development Initiative Grant (TCDI) for the amount of \$100,000 with a \$25,000 Borough match for year 2015; and

WHEREAS, the grant would be used for the purpose of transportation and parking planning.

NOW THEREFORE, BE IT RESOLVED, That the Borough Council of the Borough of Quakertown hereby authorizes the submittal of the grant application to the Delaware Valley Regional Planning Commission for the purpose of a (TCDI) grant in the amount of \$100,000 to be used for transportation and parking planning.

BE IT FURTHER RESOLVED, That the Borough Council of the Borough of Quakertown hereby authorizes matching the Transportation & Community Development Initiative Grant (TCDI) for \$25,000 which would be allocated from the 2015 budget.

Councilman Rosenberger indicated that Mr. Soost could speak at this time.

Mr. Soost asked for traffic/PennDot status on the downtown triangle project. Manager McElree stated that a meeting is being scheduled soon with PennDot regarding proposed down town traffic changes. Mr. Soost replied that the business owners should be included in the PennDot meetings.

RESOLVED, That, September 13, 2014. from 3:00 p.m. to 9:00 p.m., (rain date September 14, 2014 from 12:00 p.m. to 6:00 p.m.) has been established as "Quakertown Bike Night" for the Borough of Quakertown. This will necessitate the closing of the following streets:

- Mill Street from Fourth Street to Ninth Street;
- Fourth Street from Erie Avenue to the New Park Dead End;
- Including: Quakertown Community Pool parking lot, the skating shelter parking lot, Memorial Park and parking lot.

These roads will be closed two hours prior to the start of Bike Night and also two hours after the end of Bike Night.

WHEREAS, fireworks would be held on August 8, 2014 following Borough codes and proper permits are obtained.

NOW, THEREFORE, BE IT RESOLVED, That, the Borough Council of the Borough of Quakertown grants the request of the Quakertown Fire Department to use Memorial Park between the Tennis Courts and the Panther Playground for a carnival and the use of the band shell and dunk tank and also to hold fireworks provided that the Borough is added as additional insured on the insurance.
