A regular meeting of the Borough Council of Quakertown was held May 6, 2015, 7:28 p.m.

President Roberts called a Public Hearing to order relative to Quakertown West End Fire Company's borrowing of \$900,000 from Quakertown National Bank for the purpose of a new ariel ladder truck. This hearing is being held because the procurement of those funds is for the general well being for the health, safety and welfare of the community. The hearing was advertised in the Morning Call.

Opportunity was given for public and Council comments. There were no comments. President Roberts declared the hearing closed.

Roll call again was called for the regular Council meeting. All Council members and officers listed above were present for the meeting.

RESOLVED, That, the Financial Statement, Police Department, Zoning Administrator and Building Inspector reports be received and filed. Motion of Councilman Erwin, seconded by Councilman Propst. A roll call vote was taken and the motion was unanimously carried.

Visitors:

Steve Biddle, 130 S. Main Street indicated he would like to speak in reference to the Rail Trail project.

Ralph Moyer Jr., 207 Juniper Street, indicated he would like to speak in reference to the parking meters.

President Roberts indicated that Mr. Biddle could speak at this time. Mr. Biddle mentioned the Highlands Trail Planning Committee would like some guidance from Council and stated they would attend the June Work Session. Mr. Biddle questioned when the parking study would be complete. Manager McElree stated the parking study may be done by the end of June.

President Roberts indicated that Mr. Moyer could speak at this time. Mr. Moyer questioned why the parking meters are not fixed and what is going to be done about them. Manager McElree stated the meters are very old and parts are not made for the meters anymore. The Borough is

looking into placing a parking kiosk system but first is waiting for the parking study to be complete. Mr. Moyer inquired about the downtown trees which are damaging the sidewalks. Manager McElree stated the Economic Development Steering Committee will be proposing a tree and sidewalk plan in the near future.

PLANNING & ZONING COMMITTEE

Councilwoman Gaier stated that there are not any items for action under the Planning & Zoning Committee.

REVENUE & FINANCE COMMITTEE

RESOLVED, That the following Resolution 62-15, West End Fire Company's request for a tax exempt bond to fund a new aerial ladder truck, be adopted:

WHEREAS, in order for a bond of a volunteer fire company to qualify for tax exemption, there must be public approval of the bond under Internal Revenue Code Section 147(f); and

WHEREAS, a bond will satisfy the public approval requirement if it is approved by the governmental unit on behalf of which the bond is to be issued, in this case the Borough of Quakertown; and

WHEREAS, an issue shall be treated as having been approved by any governmental unit if such issue is approved by the applicable elected representatives of such governmental unit after a public hearing following reasonable public notice.

NOW, THEREFORE, BE IT RESOLVED, That, approval is given for bank financing in an amount not to exceed \$922,000.00 for the purchase of a new Arrow XT 100-foot aerial ladder fire truck to be located at 1319 Park Avenue, Quakertown, Pennsylvania 18951, Tax Parcel Nos. 35-004-044-001, 35-004-050 and 35-004-063, for the West End Fire Company No. 2 following a public hearing held at Borough Hall, 35 North Third Street, Quakertown, Pennsylvania on May 6, 2015 at 7:30 p.m. and is solely for the purpose of satisfying the requirements of Section 147(f) of the Internal Revenue Code.

Motion of Councilman Rosenberger, seconded by Councilman Erwin. A roll call vote was taken and the motion was unanimously carried.

RESOLVED, That, the following Resolution 69-15, considering the Memorandum of Understanding for the School Resource Officer, be adopted:

RESOLUTION 69-15

WHEREAS, the Board and Administration of the Quakertown Community School District is seeking to provide for the presence of a School Resource Officer on the various campuses of the Quakertown School District; and

WHEREAS, representatives of the Quakertown Community School District have met with representatives of the Quakertown Borough Council; and

WHEREAS, the Council of the Borough of Quakertown and the Quakertown Community School District have reached an agreement as presented in the School Resource Officer Memorandum of Understanding.

NOW, THEREFORE, BE IT RESOLVED, That, the Council of the Borough of Quakertown authorizes the Borough Manager to execute the School Resource Officer Memorandum of Understanding.

Motion of Councilman Rosenberger, seconded by Councilman Johnson. A roll call vote was taken and the motion was unanimously carried.

WHEREAS, The Congress and President of the United States have designated May 13 as Peace Officers' Memorial Day, and the week in which May 13 falls as National Police week; and

WHEREAS, the members of the law enforcement agency of the Borough of Quakertown play an essential role in safeguarding the rights and freedoms of Quakertown; and

WHEREAS, it is important that all citizens know and understand the duties, responsibilities, hazards, and sacrifices of their law enforcement agency, and that members of our law enforcement agency recognize their duty to serve the people by safeguarding life and property, by protecting them against violence and disorder, and by protecting the innocent against deception and the weak against oppression; and

WHEREAS, the men and women of the law enforcement agency of the Borough of Quakertown unceasingly provide a vital public service;
