Visitors:

Sandy Shelly, 712 Juniper Street, questioned the Moose transaction. Manager McElree stated when the Moose building was acquired there was an appraisal done by Indian Valley Appraisal Company which came in at \$370,000. The Borough acquired the property directly from the bank for \$280,000, who obtained it back from a short sale. Ms. Shelly mentioned the advertisement states the Borough can reject any bids and she assumed the Borough received several bids other than the \$110,000 bid. President Roberts stated the Borough did receive one other bid which was lower than the accepted bid. President Roberts added inside building conditions were terrible which lowered the bid.

Councilman Rosenberger mentioned the Borough also received the proceeds from the contents auctioned

from inside the Moose building.

Manager McElree added there was a lot of thought put into the purchase of the Moose building which a developer has purchased and will be renovating into business uses. The Borough should see a return on its investment from the sale of electric, water and sewer over a period of time. The renovated building will bring vibrancy to that part of Broad Street.
