Police Week / Peace Officers' Memorial Day RESOLUTION 57-16

WHEREAS, The Congress and President of the United States have designated May 15th as Peace Officers' Memorial Day, and the week in which May 15<sup>th</sup> falls as National Police week; and

WHEREAS, the members of the law enforcement agency of the Borough of Quakertown play an essential role in safeguarding the rights and freedoms of Quakertown; and

WHEREAS, it is important that all citizens know and understand the duties, responsibilities, hazards, and sacrifices of their law enforcement agency, and that members of our law enforcement agency recognize their duty to serve the people by safeguarding life and property, by protecting them against violence and disorder, and by protecting the innocent against deception and the weak against oppression; and

WHEREAS, the men and women of the law enforcement agency of the Borough of Quakertown unceasingly provide a vital public service;

WHEREAS, K-9 Jynx was acquired in April of 2008 and assigned to the K-9 unit of the Quakertown Police Department; and

WHEREAS, K-9 Jynx was trained for patrol work, building searches, officer/handler protection, tracking and explosive detection and was supported through grant funding from the Department of Homeland Security; and

WHEREAS, K-9 Jynx was assigned to Detective Matthew Molchan and as a team they had a very successful career performing numerous explosive detection searches and assisting other law enforcement agencies for the detection of evidence; and

WHEREAS, K-9 Jynx has been in active duty with the Quakertown Police Department for eight years and has served the police department and community with distinction.

NOW, THEREFORE BE IT RESOLVED, That, the Council of the Borough of Quakertown recognize K-9 Jynx's service to the police department and the Quakertown community and approve K-9 Jynx's retirement from service and transfer K-9 Jynx's care and responsibility to Detective Matthew Molchan effective immediately.

Motion of Councilman Johnson, seconded by Councilman Propst. A roll call vote was taken and the motion was unanimously carried. Councilwoman Paulovitz absent.

Manager McElree mentioned that the two new K-9 dogs Jax and Fury have been in service for less than 2 months and they already have approximately nine K-9 events that have been very successful. Included in those nine were three K-9 demonstrations and there are six more demonstrations scheduled for the next several months.

Councilman Johnson stated there are some Police Department Commendations and Recognitions to be issued tonight.

WHEREAS, the Borough of Quakertown would like to amend the Lease Agreement to a monthly fee of \$500 per month.
