

**Borough of Quakertown
Vehicle & Equipment Bid
September 16, 2016**

The Borough of Quakertown is offering the following vehicles and equipment for sale and is seeking those interested to submit a sealed bid by Friday, September 16, 2016. Each listed vehicle or equipment is a separate item and shall be bid separately.

No borough personal property may be disposed of, by sale or otherwise, except upon approval of council by resolution. In cases when council approves a sale of the property, council shall estimate the fair market value of the entire lot to be disposed of. If council estimates the fair market value to be \$1,000 or more, the entire lot shall be advertised for sale once in at least one newspaper of general circulation not less than ten days prior to the date scheduled for the opening of bids or public auction. The date of opening of bids or public auction shall be announced in the advertisement, and sale of the property advertised shall be made to the best responsible bidder.

Council may reject any bids received if the bids are believed to be less than the fair market value of the property. If no bids are received after advertisement, the applicable procedures in the act of October 27, 1979 (P.L.241, No.78), entitled "An act authorizing political subdivisions, municipality authorities and transportation authorities to enter into contracts for the purchase of goods and the sale of real and personal property where no bids are received," may be followed.

The successful bidders agree that once Council awards the bids, the successful bidders shall make payment to the Borough of Quakertown with 7 (seven) days in the form of a certified check or money order and take possession of the vehicle or equipment within 7 (seven) days of the date the bid is awarded and must comply with all applicable laws.

All bids must be submitted in a sealed envelope addressed to Scott C. McElree, Borough Manager, Borough of Quakertown 35 N. 3rd Street, Quakertown PA 18951 by no later than 11:00 a.m. on Friday, September 16, 2016. All received bids will be opened at 11:15 a.m. on Friday, September 16, 2016. Bids not received by the aforementioned instructions shall not be included in the bid process.
