One of the awareness programs are the Buddy Walks held throughout the country. There are nearly 250 taking place this year with the Lehigh Valley Buddy Walk taking place on September 24th, the Philadelphia Buddy Walk on October 2nd, and the West Chester Buddy Walk on October 9th.

BUCKS COUNTY 2016 HAZARD MITIGATION PLAN

WHEREAS, the Borough of Quakertown, Bucks County, Pennsylvania, is most vulnerable to natural and human-made hazards which may result in loss of life and property, economic hardship, and threats to public health and safety; and

WHEREAS, Section 322 of the Disaster Mitigation Act of 2000 (DMA-2000) requires state and local governments to develop and submit for approval to the President a mitigation plan that outlines processes for identifying their respective natural hazards, risks, and vulnerabilities; and

WHEREAS, the Borough of Quakertown acknowledges the requirements of Section 322 of DMA 2000 to have an approved Hazard Mitigation Plan as a prerequisite to receiving post-disaster Hazard Mitigation Grant Program funds; and

WHEREAS, the Bucks County 2016 Hazard Mitigation Plan has been developed by the Bucks County Emergency Management Agency and the Bucks County Planning Commission in cooperation with other county departments, and officials and citizens of the Borough of Quakertown; and

WHEREAS, a public involvement process consistent with the requirements of DMA 2000 was conducted to develop the Bucks County 2016 Hazard Mitigation Plan; and

WHEREAS, the Bucks County 2016 Hazard Mitigation Plan recommends mitigation activities that will reduce losses to life and property affected by both natural and human-made hazards that face the County and its municipal governments.

NOW THEREFORE BE IT RESOLVED by the governing body for the Borough of Quakertown:

- The Bucks County 2016 Hazard Mitigation Plan is hereby adopted as the official Hazard Mitigation Plan of the Borough of Quakertown; and

Mr. Wright stated he feels the American Municipal Power's (AMP) proposal is not the right decision for Quakertown and handed information to Council clarifying his opposition to Quakertown's participation in the AMP Solar project.

Councilwoman Gaier stated she feels Mr. Wright brought up some good points.

WHEREAS, the Council of the Borough of Quakertown wishes to participate in a solar generation project as proposed by American Municipal Power (AMP).

NOW THEREFORE BE IT RESOLVED by the Council of the Borough of Quakertown to authorize the Borough Manager to enter into the proposed agreement with American Municipal Power.

Motion of Councilwoman Gaier, seconded by Councilman Propst. A roll call vote was taken. The vote was 6 – 1 with Councilwoman Gaier voting no.

Councilwoman Gaier stated her vote is not because she has objection, but there is a dead line and she has more questions.

President Roberts announced the motion was passed.
