Manager McElree stated this has been a Richland Township/PennDot project not a Quakertown Borough project in place for several years and has changed a number of times delaying the project. The Borough presently is in the arduous process of obtaining easements from property owners at the different intersection locations.

Councilman Rosenberger mentioned there will not be an increase in the Borough's utility rates or taxes.

Motion of Councilman Rosenberger, seconded by Councilman Johnson. A roll call vote was taken and the motion was unanimously carried.

Councilman Rosenberger stated the next item was not on the agenda. The Borough is interested in changing insurance carriers for all insurances other than medical and health insurance to Delaware Valley Insurance Trust (DVIT). With similar or better coverage than what the Borough has currently, the price with (DVIT) will be approximately \$95,000.00 less. If interested, the Borough would have to change companies before January 1, 2017.

Councilman Rosenberger made a motion for a Resolution to move forward with the insurance company change and if adopted an Ordinance would need to be passed. Councilman Rosenberger asked President Roberts to adjourn this meeting to later this month so there is time to advertise the Ordinance and vote on it.

President Roberts added the Ordinance is required to establish the Borough Manager as a trustee which is required for each participating municipality in the Delaware Valley Insurance Trust.

RESOLVED, That the following Resolution 128-16, participation in the Delaware Valley Workers' Compensation Trust, be adopted:

## **RESOLUTION 128-16**

WHEREAS, the Borough Manager has researched various insurance providers relative to the Borough's General Liability and Workers' Compensation Insurance; and

WHEREAS, the Borough Manager has made the determination to change the insurance provider to Delaware Valley Workers' Compensation Trust.

Michael Cygan stated pancreatic cancer is one of the primary causes of cancer death in the United States, 46,000 people a year are diagnosed and only 6% of those will survive over 5 years. This fund raising event in the last two years has raised \$56,000 for pancreatic cancer research at Jefferson Hospital.

Councilman Propst asked Council if they had questions or feedback on the proposed trail signs from the Appalachian Mountain Club. Borough Manager McElree stated he was anticipating the updated design but has not received it. President Roberts replied this will be discussed further when the information is received.

Borough Manager McElree mentioned on December 15, 2016 the police will be hosting the 6<sup>th</sup> annual Shop With A Cop at Walmart. This year \$25,000 has been raised and the program has been expanded adding additional police departments and increasing the number of children participating to sixty. Borough Manger McElree thanked all the sponsors, businesses, police officers and Julie Bender who help make this event successful.

Councilwoman Gaier stated this is a fantastic night and special event.
