A regular meeting of the Borough Council was held August 6, 2008, 7:30 p.m.

The following members and officers were present: President L. James Roberts, Vice President Donald Rosenberger, Councilmembers Michael Johnson, Michelle Scarborough, Edward Scholl, Daniel Williams, and David Zaiser, Solicitor Charles Fonzone, Manager Scott C. McElree and Asst. Borough Secretary Phyllis R. Ewing.

RESOLVED, That, the following check registers be approved for payment:

Motion of Councilman Rosenberger, seconded by Councilman Williams.

Councilman Roberts stated that he will abstain from voting on the approval of the check registers because it includes the purchase of items from the Friendly Book Store and that he has signed a letter in this regard.

A roll call vote was taken and the motion carried with the following Councilmembers voting in favor: Johnson, Rosenberger, Scarborough, Scholl, Williams and Zaiser; and the following Councilmember abstaining: Roberts.

RESOLVED, That, the Police Department, Zoning Administrator and Building Inspector reports be received and filed. Motion of Councilman Williams, seconded by Councilman Zaiser. A roll call vote was taken and the motion was unanimously carried.

Visitors:-

Michael Fredericks of 456 S. 9th Street, Robert Fry of 448 S. 9th Street, Mike Orzel of 1024 Park Avenue, Sasha Styles of 328 E. Broad Street, Merrill Stoudt of 304 S. 9th Street, Eric Barnes of 461 S. 10th Street and Jim Roth of 220 Franklin Street indicated they wished to speak with regard to proposed Ordinance 1145.

John Leonard of 149 N. 9th Street stated that he wishes to speak under the Public Works Committee portion of the agenda.

PLANNING & ZONING COMMITTEE

Councilman Scholl invited those wishing to speak, to speak at this time.

Michael Fredericks stated that he feels that Section 9 of the proposed Ordinance 1145 is a disrespect for our civil rights and is unreasonable search and seizure.

Robert Fry stated that according to Sections 9 and 10, if the landlord doesn't pay, it will fall on the tenant. Mr. Fry indicated that he feels it is discrimination to require inspection only of rental dwelling units.

Mike Orzel stated that in his business 40% of his customers are renters, and in speaking to them, they indicated that they feel it infringes on their privacy and that there are other avenues rather than inspection.

Sasha Styles told Council that she feels Sections 1 and 9 violate the fourth amendment and in regard to Section 9, people can't afford this.

Merrill Stoudt stated that he feels people coming in while someone is living there is an invasion of their privacy. Mr. Stoudt told Council that he feels inspections should be done when no one is living at the property.

Eric Barnes stated that he opposes this ordinance and if there would be anything unsafe, he would go to his landlord. Mr. Barnes questioned the checklist and asked what some of the items listed have to do with the safety of the people?

Jim Roth urged Council to vote against Ordinance 1145. Mr. Roth told Council that every time he reads the Ordinance, he finds new problems with it.

RESOLVED, That, reading of Ordinance 1145 pertaining to Residential Rental Dwelling Units be waived. Motion of Councilman Scholl, seconded by Councilman Rosenberger. A roll call vote was taken and the motion was unanimously carried.

RESOLVED, That, Ordinance 1145, an Ordinance requiring landlords to annually register all residential rental dwelling units owned by such landlords in the Borough of Quakertown and the occupants of each such rental dwelling unit, and to report occupancy physical changes to such rental dwelling units; fixing the registration/inspection fee; further providing for a periodic inspection of all residential rental dwelling units for compliance with Borough Codes and Ordinances; providing fines and penalties for violations; repealing all other inconsistent Ordinances, be passed finally. Motion of Councilman Scholl, seconded by Councilman Zaiser.

Under discussion, Councilman Williams stated that he has been against this Ordinance from the beginning and indicated that he feels an Ordinance is needed for inspections, but of empty units and not occupied units.

Councilman Scholl stated that renters have approached him that are happy with this Ordinance. Councilman Scholl stated that he feels this Ordinance is a good thing.

Councilman Zaiser stated that he is in agreement with Councilman Scholl. Councilman Zaiser stated that if Council could spare one person from living in a bad situation, such as bad electrical wiring, that is a good thing.

Councilman Rosenberger stated that he is not a big fan of this Ordinance and agrees with some of Councilman Williams' statements. Councilman Rosenberger stated that Council could vote for this tonight and if it is found six months from now that it is a disaster, it could be repealed or fine-tuned.

A roll call vote was taken and the motion carried by majority vote with the following Councilmembers voting in favor: Johnson, Rosenberger, Scarborough, Scholl, Zaiser and Roberts; and the following Councilmember voting against: Williams.

Councilman Scholl indicated the next item on the Agenda is Ordinance 1146. Atty Labosky indicated a desire to speak on this Ordinance.

Atty. Gavin Labosky spoke, on behalf of Robert A. Rush, regarding amending the zoning classification of Tax Parcel 35-008-143 from Medium Residential (MR) to Town Center (TC). Atty. Labosky pointed out that both the Bucks County Planning Commission and the Quakertown Planning Commission recommend approval of the zoning change. Atty. Labosky stated that 17 neighbors had petitioned against the change, but he feels their petition is based on inaccuracies since this is a simply a request to change the zoning.

Councilman Scholl asked if Dr. Rush's son is opening some kind of business at that location? Atty. Labosky stated that is something Dr. Rush's son would like to pursue in the future and pointed out that can only happen if he meets the regulations of the Zoning Ordinance.

RESOLVED, That, reading of Ordinance 1146, amending the zoning classification of Parcel 35-8-143 from the MR to TC district, be waived. Motion of Councilman Scholl, seconded by Councilman Rosenberger. A roll call vote was taken and the motion was unanimously carried.

RESOLVED, That, Ordinance 1146, an Ordinance of the Borough of Quakertown, Bucks County, Pennsylvania, amending the Borough of Quakertown Zoning Ordinance and map by amending the zoning classification of Parcel #35-8-143 from the MR - Medium Residential classification to the TC - Town Center district on the said zoning map, and the zoning classification of Parcel #35-8-143 from the MR - Medium Residential classification to the TC - Town Center district for the property located at 600 West Broad Street, Quakertown, Pennsylvania 18951, be passed finally. Motion of Councilman Scholl, seconded by Councilman Rosenberger.

Councilman Zaiser stated that last year Council changed the parking restrictions for Town Center businesses and that was with retail, correct? President Roberts indicated that it was

restaurants and retail. Councilman Zaiser stated that before the parking restrictions were changed, Town Center required so much off-street parking per square foot. Councilman Zaiser indicated that his concern is now if this property becomes retail, the parking concerns are an issue. Atty. Labosky indicated that he believes, based on that property and the existing buildings that are there, that it is almost impossible to make that economically viable as a retail establishment and is not Dr. Rush's immediate plan. Atty. Labosky pointed out that the Ordinance requires certain square footage and amenities that are required for retail and he is not close to coming into compliance with any of the retail requirements.

Councilwoman Scarborough stated that perhaps with regard to the concerns of residents on the parking issue, is it possible, in the future, that a sign could be put up from Apple Street back indicating "residential parking only"? Councilwoman Scarborough stated it is a thought for Council to consider in the future.

A roll call vote was taken and the motion was unanimously carried.

RESOLVED, That, the following Resolution 98-08 pertaining to rental inspection polices and procedures be adopted:

RESOLUTION NO. 98-08

WHEREAS, the Borough has prepared a "Rental Property Inspection Policy and Procedure" to establish the administration of a rental inspection program, the operational structure of a rental inspection program, and the appeal and remedy process regarding uncorrected violations.

NOW, THEREFORE, BE IT RESOLVED, That, the Borough Council of the Borough of Quakertown does hereby adopt the new policy entitled "Rental Property Inspection Policy and Procedure" to be effective August 7, 2008.

Motion of Councilman Scholl, seconded by Councilman Zaiser. A roll call vote was taken and the motion was unanimously carried.

Councilman Scholl indicated that the next item on the agenda, discussion of an Adult Use Ordinance, is tabled until the August Work Session.

RESOLVED, That, the following Resolution 101-08, pertaining to the resignation of Johan Anestad from the Borough of Quakertown Planning Commission, be adopted:

NOW, THEREFORE BE IT RESOLVED, That, the Council of the Borough of Quakertown approves, with thanks, the resignation of Johan Anestad from the Borough of Quakertown Planning Commission.

Motion of Councilman Scholl, seconded by Councilwoman Scarborough. A roll call vote was taken and the motion was unanimously carried.

RESOLVED, That, the following Resolution 102-08, pertaining to the appointment of Philip Abramson to the Borough of Quakertown Planning Commission, be adopted:
