President Roberts asked that Council's thanks be conveyed to the organization

Lindsay Bowers, 27 S. Main Street, Rear Apt., Quakertown, Pennsylvania, was sworn in as a Fire Policewoman by Manager McElree.

President Roberts announced that our newest K-9 addition to the Police Department, Jinx, will perform a demonstration along with his handler, Officer Cassie Zliceski. Officer Zliceski and Jinx performed a demonstration whereby Jinx sniffed out and found a black powder, previously hidden. Officer Zliceski indicated that Jinx is a bomb dog, a patrol dog, which means he does searching for children and the elderly, and also apprehension. Manager McElree told Council that they had close to 100 incidents where the K-9's needed to be used. Manager McElree stated that K-9 Kito is cross-trained in drug detection. Kito took a pound of marijuana off the street during a car-stop. K-9 Jinx had been most recently used for a warrant search and also tracking.

A RESOLUTION CONDITIONALLY APPROVING THE SUBDIVISION AND LAND DEVELOPMENT PLAN OF GIANT FOOD STORES, LLC LOCATED IN THE QUAKERTOWN PLAZA

WHEREAS, Giant Food Stores, LLC, has submitted a Land Development Plan for preliminary/final approval to the Borough Council of the Borough of Quakertown; and

WHEREAS, on October 13, 2008 the Planning Commission approved the Plan subject to the following conditions:

- 1. The Developer shall address those items reviewed by the Planning Commission and discussed at the October 13, 2008 meeting as follows:
 - a. The plan needs notations to the exact location of landscaping trees and species.
 - b. The sign for the facility has to be in compliance with the Borough's sign ordinance.
 - c. The facility should have some extra buffering to make it more attractive on the W. Broad Street side.
 - d. The sewage planning modules must be coordinated with the State.

- e. The canopy will be about 17 feet total for one sign.
- f. A manhole must be installed where the proposed pressurized sanitary sewer lateral from the grinder pump connects to the existing lateral at W. Broad Street.
- g. The size of the waterline must be determined prior to any construction taking place.
- h. The Storm Sewer Roof Leader Connection detail shown must be removed and a detail added showing a prefabricated tee or wye for this connection must be shown.
- i. Trip Classification Percentages, Jarred Neal from Traffic Planning and Design, Inc. clarified that there are three ways to classify a trip; new, pass by and internal capture trips. Cowan's letter wants clarification that pass by trips were calculated in the driveway calculations. Mr. Neal replied that pass by trips were and that it does operate at expectable levels of service (which means the time that someone has to wait). Mr. Neal will address and clarify Cowan's comments and feels it will not be an issue. The traffic study conforms to all the standards that are set by PennDOT. A question was asked as to the days and hours used for the traffic study. Mr. Neal explained prior to the study, they discussed with Cowan under what conditions they wanted, the study done and Cowan requested Tuesday, Wednesday or Thursday with peak hours being 7:30-8:30 a.m. and 4:15-5:15 p.m. Mr. Neal further explained several other areas of the study to the Planning Commission members.
- j. An escrow account would be established to cover costs of improvements.
- 2. The Developer is responsible to secure the appropriate insurance as required by the PennDOT permit, to the satisfaction of the Borough of Quakertown and PennDOT.
- 3. The Developer shall be required to enter into the necessary Subdivision and Land Improvements and Maintenance Agreements for any public improvements or those to be inspected by the Borough Engineer. Part of these Agreements will be the posting of construction and inspection security to assure proper completion of said improvements, as well as providing proper insurance certificates.

NOW, THEREFORE, BE IT RESOLVED that the Land Development Plan of Giant Food Stores, LLC #476-Fuel Island, is hereby approved subject to the here and above noted conditions: and

The conditions of approval have been made known to the Applicant and final approval is to be deemed expressly contingent upon Applicant's affirmative written acceptance of the conditions of approval on a form prescribed by the Borough of Quakertown within twenty (20) days of the date hereof.

In the event that the statutory review period for this subdivision or land development, as set forth in the Municipalities Planning Code, should expire prior to the end of the twenty (20) day response period, the Applicant's written acceptance of the conditions of approval should be tendered PRIOR to the expiration of the statutory review period, even if such period expires less than twenty (20) days from the date of this resolution. The response period shall be deemed to expire on October 27, 2009.
