President Roberts pointed out that waiting a month for a report may be too late when it comes to utility payments. Mr. Drobins stated that as a resident of the Borough, he asks that this ordinance not be adopted.

SUPPORT OF THE HIGHLANDS CONSERVATION ACT AND PROTECTION OF THE HIGHLANDS REGION IN PENNSYLVANIA

WHEREAS, the Highlands region, encompasses more than three million acres of Pennsylvania, New York, New Jersey and Connecticut; and

WHEREAS, the Highlands region is an area of national significance, possessing significant natural beauty, containing contiguous forest and productive farmland, numerous cultural and historic sites, substantial recreational opportunities, and the protection and supply of important drinking water sources for over fifteen million people; and

WHEREAS, the U S Congress, in bipartianship, passed the Highlands Conservation Act, Public Law 108-421 that was signed into law by the President of the United States on November 30, 2004, designating the Highlands as a significant national conservation priority region; and

WHEREAS, the Highlands Conservation Act authorizes the Secretary of the Interior and the Secretary of Agriculture to provide financial assistance to Highlands States to preserve and protect high priority conservation land in the highland region; and

WHEREAS, the United States Forest Service will continue programs and assist Highlands states, local units of government, and private forest and farm landowners in the conservation of land and natural resources in the Highlands region; and

WHEREAS, land preservation efforts in the Highlands region should link the parks, historic sites, wetlands, wildlife habitats, streams, rivers, reservoirs, watersheds, trails, scenic and natural lands and other protected areas unique to the region for the enjoyment of future generations; and

WHEREAS, the Commonwealth of Pennsylvania has designated the Highlands as one of five Mega-greenways in the state of Pennsylvania; and

WHEREAS, the counties of Adams, Berks, Bucks, Chester, Cumberland, Dauphin, Franklin, Lancaster, Lebanon, Lehigh, Montgomery, Northampton, York, are local units of government containing portions of the Highlands region in Pennsylvania. NOW THEREFORE BE IT RESOLVED that the Council of the Borough of Quakertown, Bucks County, Commonwealth of Pennsylvania supports the implementation of the spirit and intent of the Highlands Conservation Act and the protection of the Highlands region in Pennsylvania as an area rich in natural resources, which are important to the environmental quality and economic prosperity within our Borough.

RESOLUTION NO. 36-09

RESOLUTION OF QUAKERTOWN BOROUGH AUTHORIZING THE EXECUTION OF A CABLE FRANCHISE AGREEMENT BETWEEN THE BOROUGH AND VERIZON PENNSYLVANIA, INC.

WHEREAS, pursuant to Title VI of the Communications Act (see 47 U.S.C. § 601 et seq.), the Cable Television Consumer Protection and Competition Act of 1992, and the Telecommunications Act of 1996, the regulations of the Federal Communications Commission and Pennsylvania law, Quakertown Borough in Bucks County is authorized to grant franchises to construct, operate and maintain a cable system utilizing public rights-of-way and properties within the Borough's jurisdiction; and

WHEREAS, Verizon of Pennsylvania, Inc. ('Verizon') is upgrading its existing telecommunications system under Title II of the Communications Act (see 47 U.S.C. §201 et seq.) and has applied for a non-exclusive cable franchise from the Borough to operate a cable system under Title VI of the Communications Act (see 47 U.S.C. §521 et seq.); and

WHEREAS, Verizon is in the process of installing a Fiber to the Premise Telecommunications Network (FTTP Network') in the Borough for the transmission of non-cable services pursuant to authority granted by the Commonwealth of Pennsylvania; and

WHEREAS, the FTTP Network will occupy the public rights-of-way within the Borough, and Verizon desires to use portions of the FTTP Network once installed to provide cable services in the Borough; and

WHEREAS, the Borough desires to protect and manage the public rightsof-way, require high standards of customer service, receive financial compensation for Verizon's use of the public rights-of-way as provided by federal law, obtain complimentary services for its public buildings, obtain educational and governmental channels, establish certain reporting requirements, and provide for the future cable-related needs of its residents; and

WHEREAS, the Borough has determined Verizon to be financially, technically and legally qualified to operate the cable system to provide cable services; and

WHEREAS, the Borough has determined that the public interest would be served by granting a franchise to Verizon according to the terms and conditions contained in the Cable Franchise Agreement (the "Agreement") negotiated with representatives of Verizon.

NOW THEREFORE, BE IT RESOLVED by the Quakertown Borough Council as follows:

SECTION 1. Grant of Franchise; Execution of Franchise Agreement.

The Borough hereby grants Verizon a non-exclusive cable franchise subject to and in accordance with the terms and conditions of the Agreement. A copy of the Agreement is attached hereto and made a part hereof as Exhibit A.

SECTION 2. Other Franchises Unaffected.

Nothing in this Resolution, including the Agreement, shall alter the terms of any other franchise previously granted by the Borough, each of which shall remain in effect according to their particular terms and conditions.

SECTION 3. Severability.

If any section, subsection, sentence, clause, phrase or word of this Resolution is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not render this Resolution invalid. Motion of Councilman Roberts, seconded by Councilman Williams.

Councilwoman Scarborough stated that this is a twelve year contract with a right of termination after three years.

Mary Lou Free answered that there is a clause that Verizon may opt out if it finds that it is not a viable service. Ms. Free pointed out that they have been in business over three years and its been viable. Mr. Copiz pointed out that Verizon has the opt out, but the Borough does not.

A roll call vote was taken and the motion was unanimously carried (Councilman Rosenberger — absent).

President Roberts declared the meeting adjourned.
