A regular meeting of the Borough Council was held August 4, 2010, 7:30 p.m.

The following members and officers were present: President L. James Roberts, Vice President Donald Rosenberger, Councilmembers David Erwin, Michael Johnson, Michelle Scarborough and Daniel Williams, Solicitor Charles Fonzone, Manager Scott C. McElree and Asst. Borough Secretary Phyllis R. Ewing.

RESOLVED, That, the Minutes of July 7 and 26, 2010, be approved as written. Motion of Councilman Rosenberger, seconded by Councilman Erwin. A roll call vote was taken and the motion was unanimously carried (Councilman Scholl absent).

President Roberts stated that he will abstain from voting as a purchase was made from the Friendly Book Store.

A roll call vote was taken and the motion carried with the following Councilmembers voting in favor: Erwin, Johnson, Rosenberger, Scarborough and Williams; and the following Councilmember abstaining: Roberts (Councilman Scholl absent).

RESOLVED, That, the Police Department, Zoning Administrator and Building Inspector reports be received and filed. Motion of Councilman Williams, seconded by Councilman Johnson. A roll call vote was taken and the motion was unanimously carried (Councilman Scholl absent).

At 7:35 p.m., President Roberts called the public meeting regarding the National Register Nomination to order and indicated that Preservation Consultant Ms. Kathryn Ann Auerbach will give a presentation. President Roberts stated that following the presentation, Council and members of the audience will be able to present questions and/or comments.

Ms. Auerbach, with the use of a map, pointed out the boundaries of the Quakertown Historic District. The Quakertown Historic District is scheduled for review on October 5th. Ms. Auerbach expounded on the history of Quakertown and the National Register.

Mr. Steve Biddle, 130 S. Main Street, commented on the Historic District and the

National Register.

President Roberts asked if anyone had any other comments or questions and indicated that by their silence, he is taking it that everyone is in agreement with this endeavor. At 7:55 p.m., President Roberts declared the public meeting portion of the meeting adjourned.

PLANNING & ZONING COMMITTEE

In Councilman Scholl's absence, Councilwoman Scarborough chaired the Planning & Zoning Committee portion of the agenda.

Councilwoman Scarborough stated that the first item on the agenda is with regard to an open container ordinance, which has been advertised.

RESOLVED, That, reading of Ordinance 1172, regarding open containers, be waived. Motion of Councilwoman Scarborough, seconded by Councilman Rosenberger. A roll call vote was taken and the motion was unanimously carried (Councilman Scholl absent).

RESOLVED, That, Ordinance 1172, an ordinance prohibiting the drinking of "alcoholic beverages" upon any public access property, or in any vehicle being operated or parked thereon, and to prohibit any person to have in such person's possession or in any vehicle under such person's control, any open container containing an "alcoholic beverage" upon any public access property; and to provide penalties for the violation thereof, be passed finally. Motion of Councilwoman Scarborough, seconded by Councilman Rosenberger. A roll call vote was taken and the motion was unanimously carried (Councilman Scholl absent).

RESOLVED, That, the following Resolution 87-10, regarding the National Register Nomination, be adopted:

RESOLUTION 87-10

WHEREAS, the Council of the Borough of Quakertown voted on September 1, 2004, to support the efforts of Quakertown Alive to create a National Historic District Register; and

WHEREAS, the Council of the Borough of Quakertown has held a public meeting regarding the community's position on having the Historic District Area of the Borough listed in the National Register of Historic Places,

NOW, THEREFORE, BE IT RESOLVED, That, we renew our commitment to the Resolution of September 1, 2004.

Motion of Councilwoman Scarborough, seconded by Councilman Erwin. A roll call vote was taken and the motion was unanimously carried (Councilman Scholl absent).

REVENUE & FINANCE COMMITTEE

Councilman Rosenberger stated that ChesMont Disposal of Skippack, Pennsylvania, is contemplating being acquired by a larger company and are requesting that the Borough consent to assign the three-year contract to their potential new owners. Councilman Rosenberger further stated that the Consent Assignment has been reviewed by the Borough Solicitor and the Borough Manager. Before Council ultimately accepts the assignment, IESI PA Corporation will provide certain financial information, information on their background as to litigation and some other items. The Resolution allows the Borough Manager to collect that information and sign the consent.
