PLANNING & ZONING COMMITTEE

RESOLVED, That, the following Resolution 68-10, Quakertown Area Planning Committee, be adopted:

RESOLUTION NO. 68-10

The Quakertown Area Planning Committee ("the QAPC") is a regional planning committee comprised of members from the Townships of Haycock, Milford, and Richland, the Boroughs of Quakertown, Richlandtown, and Trumbauersville and the Quakertown Area School District (collectively the "Participating Municipalities and School District") and has operated as an advisory planning committee since 1972, at which time it was established by resolution.

This resolution serves as an update to previous resolutions in regards to committee membership, duties, and expense allocation by all member municipalities and the Quakertown Community School District. The QAPC shall be authorized to do planning work on common problems, including, but not limited to: land use, water, sewers, schools, highways, flooding, and ordinances; and provide recommendation concerning any of the following that may be submitted by the participating municipalities in the Committee:

- a. Amendments to the area subdivision and land development ordinance or to the area zoning ordinance.
- b. All planned residential developments, performance standards subdivisions, and cluster subdivisions.
- c. All requests for conditional uses or special exceptions involving developments on more than 5 acres.
- d. All sketch and preliminary subdivision or land development plans of nonresidential developments involving more than 5 acres or residential developments of 25 acres or more dwelling units.

The Quakertown Area Planning Committee consists of thirteen appointed members: two from each municipality and one from the Quakertown Area School District. Each municipality shall be represented by one member of the local planning commission and one member from the local governing body. The school district and the municipalities may furnish alternate members that may vote when appointed members are not in attendance. Only one vote may be recorded from the school district and from each municipality. The terms of all members shall be concurrent with the individual's elected or appointed terms in the municipality except that such terms may be terminated by action of the local governing body.

WHEREAS, the QAPC has issued a description outlining their purposes and relationship to the participating communities in the QAPC.

NOW, THEREFORE, BE IT RESOLVED, That, the Borough Council of the Borough of Quakertown agrees with the aforementioned description and participation of the Borough of Quakertown in the Quakertown Area Planning Committee, and;

BE IT FURTHER RESOLVED, That, the Borough Council of the Borough of Quakertown agrees to pay 13.5%, a proportionate amount of expenses incurred by the Quakertown Area Planning Committee known as the expense allocation, for such a time that all aforementioned participating municipalities agree to pay said expense allocation.

Motion of Councilman Scholl, seconded by Councilwoman Scarborough. A roll call vote was taken and the motion was unanimously carried.
