A regular meeting of the Borough Council of Quakertown was held February 1, 2017, 7:30 p.m.

The following members and officers were present: President L. James Roberts, Vice President Donald Rosenberger, Council members Lisa Gaier, Michael Johnson, Jann Paulovitz, Douglas Propst, Jon Roth, Solicitor Charles Fonzone, Manager Scott C. McElree and Asst. Borough Secretary Kris Barndt.

Naomi Nayor, Director of Quakertown Alive! and Lynda Ulrich, Events Chairperson presented a \$700.00 check, proceeds from the Autumn Alive Event, to the Borough's K-9 Unit. Councilman Johnson thanked Quakertown Alive! and stated the K-9 Unit could not stay functional without these types of donations. Officer Houseknecht and his partner Fury were also present. Councilman Johnson mentioned last week the Borough lost K-9 Jynx, who was recently retired.

RESOLVED, That, the Minutes of January 4, 2017 and the minutes from the continued meeting on January 23, 2017 be approved as written. Motion of Councilman Rosenberger, seconded by Councilwoman Paulovitz. A roll call vote was taken and the motion was unanimously carried.

RESOLVED, That, the Financial Statement, Police Department, Zoning Administrator and Building Inspector reports be received and filed. Motion of Councilman Propst, seconded by Councilman Johnson. A roll call vote was taken and the motion was unanimously carried.

Visitors:

The majority of the visitors were attending the meeting concerning a letter which was sent to them from the Borough regarding their sanitary sewer lateral which had failed inspection. Several residents in attendance were:

Thomas Mitchell, 705 W. Broad Street Michael Siatkiowski, 909 W. Broad Street Justin Secreto, 715 W. Broad Street Wilbur Aikey, 731 W. Broad Street John Healey, 927 W. Broad Street

Stephen Biddle, 130 S. Main Street, indicated he would like to speak regarding the downtown pedestrian plan.

Manager McElree briefed the audience concerning the reason why their laterals were tested.

The Department of Environmental Protection is the agency which sees the Borough is abiding by regulations set for our wastewater treatment plant. Manager McElree explained the Borough's infrastructure is old and the wastewater plant is being overloaded by excessive stormwater and rainwater. The majority of sanitary sewer laterals are made of clay which were installed around the year 1925 or earlier and clay pipe is not made to last this long. The Borough and DEP have a corrective action plan to make sure the environment is safe and to save on extra treatment costs which affects every parcel owner in the Borough.

Manager McElree stated the Borough will work with the residents and will extend the 100 day dead line within reason. He suggested having several neighbors schedule their lateral replacements together to help lower the cost.

Manager McElree recommended holding a meeting with the residents in the near future for further questions and concerns and to share specific information and pictures on their lateral inspection. He also advised the residents to bring estimates they receive for their replacements. Contractors are welcome to attend the meeting. Thomas Mitchell, resident on Broad Street will be the contact person between the Borough and residents.

Councilwoman Gaier indicated Mr. Mitchell could speak at this time. Mr. Mitchell expressed his and his neighbor's financial concern, the dead line to comply, proof of their pipe damage, and a request to perhaps increase the \$500.00 reimbursement.

A question was asked if a resident can do the replacement on their own. Manager McElree answered yes if they are capable of doing so.

President Roberts called a five minute recess.

PennDot is now requiring pedestrian controls at the intersections of 3rd Street & Broad Street, 4th Street and Broad Street and Front Street and Broad Street and is requiring a study on pedestrian crossings.

Councilman Rosenberger indicated Stephen Biddle could speak at this time. Mr. Biddle stated he would like the Borough to consider including the planner for the Highlands Trail for feedback and to aid with bicycles and traffic off and on the sidewalks before the study goes to PennDot. Mr. Biddle recommends the pedestrian study to include the intersection at Broad and Branch Streets, Broad and Front Streets and at the railroad tracks since the Borough is encouraging pedestrian commerce from the antique district to down town.

RESOLVED, That, the following Resolution 21-17, downtown pedestrian plan update, be adopted:

WHEREAS, an engineering proposal has been received regarding a revision to the initial downtown traffic design from Traffic Planning and Design, Inc. dated January 23, 2017, to include pedestrian traffic controls, with an amount not to exceed \$11,000.00; and

WHEREAS, this proposal indicates a scope of work comprised of updated analyses relating to the establishment of back-in angle parking along Branch Street which will be forwarded to PennDOT for their concurrence, revised traffic signal permit plans to include countdown pedestrian signal indications, modify the traffic signal timings to include separate timing plans to accommodate the traffic flow during peak conditions and where necessary increase vehicular signal heads from 8 inch to 12 inches and also includes a complete pavement marking plan and a probable construction cost.

NOW, THEREFORE, BE IT RESOLVED, That, the Council of Quakertown Borough does hereby accept the proposal from Traffic Planning and Design, Inc. dated January 23, 2017 and hereby authorizes the Borough Manager to execute the said proposal on behalf of the Borough of Quakertown.
