Audrey Wadsworth, 620 W. Broad Street, indicated she would like to speak regarding social media and trash service complaints. Ms. Wadsworth stated she supported Council on Facebook with resident complaints stating they are not aware of what is happening with Council meetings. Ms. Wadsworth suggested making the minutes on the Borough's website more easily accessible. Manager McElree stated the minutes are posted next to the agendas after they are approved by Borough Council, which is a month delayed until the minutes can be posted. Manager McElree replied he would look into adding Council meeting information on the front page of the website.

Councilman Sell stated that there are not any items under the Planning & Zoning Committee.

REVENUE & FINANCE COMMITTEE

Vice President Roberts announced the Borough's Municipal Minimum Obligations for the year 2020. Police pension \$572,394.00, Non-uniform pension \$181,090.00 and Money Purchase plan (401A) \$109,200.00, for a total of \$862,684.00.

WHEREAS, the Borough agrees to provide access to the library parking lot by paving a driveway from an already existing curb cut to be used when the 4th Street access is blocked.

NOW, THEREFORE BE IT RESOLVED, That, the Council of the Borough of Quakertown does hereby authorize the proper officials to sign the Agreement for the Donation of Real Estate between Bucks County of 55 East Court Street, Doylestown and the Borough of Quakertown.

Motion of Vice President Roberts, seconded by Councilman Sell. A roll call vote was taken and the motion was unanimously carried.
