WHEREAS, in conjunction with adopting this LERTA Ordinance, the Borough also designated areas within the Borough as "deteriorated" within which the LERTA Program would be effective and attached a map showing these areas to the LERTA Ordinance as Attachment A; and

WHEREAS, Borough Council has determined that the current Attachment A incorrectly Illustrates the deteriorated areas within the Borough by failing to show the property located at 1409 West Broad Street, also known as, Bucks County Tax Map Parcel #35-002-042, as being deteriorated as Borough Council intended when it adopted the LERTA Ordinance; and

WHEREAS, Borough Council desires to correct the error on Attachment A to properly reflect all of the deteriorated areas that existed within the Borough when the LERTA Ordinance as adopted; and

WHEREAS, Borough Council desires to designate the property located at 1409 West Broad Street, also known as, Bucks County Tax Map Parcel #35-002-042 as deteriorated and thus covered By the LERTA Ordinance.

NOW THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Quakertown as follows:
