A regular meeting of the Borough Council of Quakertown was held June 2, 2021, 7:30 p.m.

The following members and officers were present: President Donald Rosenberger, Vice President James Roberts, Councilmembers Jonathan Sell, Mae Wear, Michael Johnson, David Wilsey, Douglas Propst, Solicitor Peter Nelson, Manager Scott C. McElree, Asst. Borough Secretary Kris Barndt and Junior Councilmember Mason Smith.

RESOLVED, That, the Council Minutes of May 5, 2021 & Work Session Minutes of April 26, 2021 be approved as written. Motion of Vice President Roberts, seconded by Councilman Propst. A roll call vote was taken and the motion was unanimously carried.

Motion of Councilman Propst, seconded by Councilman Johnson. A roll call vote was taken and the motion was unanimously carried. Vice President Roberts, abstained.

RESOLVED, That, the Financial Statement, Police Department, Zoning Administrator and Building Inspector reports be received and filed. Motion of Councilman Wilsey, seconded by Councilman Propst. A roll call vote was taken and the motion was unanimously carried.

Visitors:

Stephen Biddle, 130 S. Main Street, would like to speak regarding a future car show which is scheduled to take place in the Borough.

A zoom presentation was held with various representatives from Myrtha Pools USA to review their proposal for the Borough public pool. The pool is eighteen years old and Myrtha Pools originally built it. Their proposal is to completely rehabilitate the pool, putting it in like-new condition. The Borough has asked Myrtha Pools to take a look at expanding the facility and incorporate potentially other bodies of water and other water features, which is currently in the planning phase. This work is proposed to be completed in conjunction with the renovations of the existing pool. Myrtha would plan to start working on the pool rehabilitation within the next two months, as soon as they would get approval from the Borough. The additional expansion would have to go through the design permitting process.

President Rosenberger asked if the rehabilitation were to begin in August when could the Borough open the pool next year. Myrtha stated the Borough asked for two separate schedules, one being for the remediation of the existing pool which they are ready to start but need thirty days lead time to get materials and labor. That work can be started and finished in one month. The expansion of the facility is more time consuming because of the design and permitting process. The Borough has asked for both processes to run in parallel and both projects to be completed in order to open up the facility combined and finished for Memorial Day 2022.

President Rosenberger asked what the length and coverage of the warranty would be. Myrtha's representative explained the structural warranty on the existing steel currently in the pool is still intact which has a twenty five year warranty from the date of the installation which was eighteen years ago. Myrtha will re-extend that warranty for an additional ten years. All of the new components that will be installed such as pvc finishes, markings and coping will be a day one new ten year warranty.

Manager McElree asked what the life expectancy of the pool would be. Myrtha replied in an outdoor environment that is high UV, which Quakertown falls under that category, the pvc components should last another twenty to thirty years from the day it is completed. This range depends on the water chemistry. The structural steel will never change.

President Rosenberger asked if the supply chain is doing okay in the pool industry. Myrtha answered yes, they have resources being the largest pool manufacturer in the world. The only exception would be if the Borough were to select specific toy equipment or specific accessories which are uncommon.

Manager McElree mentioned if Council indicates that the Manager should move forward, the Borough's Solicitor and Myrtha are presently working on the completing the contract such as prevailing wages, this would be brought back to the Work Session as a possible action item in July. A meeting is scheduled this week to discuss the expansion project such as a baby pool, a new slide, a climbing wall and splash pad. Manager McElree believes he will be prepared to bring that to the Work Session as well and possibly Myrtha can start on the project in August and parallel that work to get it completed by next season.

Councilman Wilsey mentioned on hot days there is not enough shade and suggested serious consideration for shade structures.

President Rosenberger asked if a contract with Myrtha would be ready this month then this current meeting could be adjourned to the June's Work Session so that item can be voted on and the project could get started. Solicitor Nelson explained tonight Council could pass a motion advising Myrtha to move ahead pending the finalization of the contract that will be approved at the June Work Session giving Myrta their lead time to get started.

Manager McElree stated the quotation to rehabilitate the pool is \$300,000.00 which does not include the prevailing wage or some of the cost of the bonds.

RESOLVED, That, the following Resolution 73-21, authorization for the Borough Manager and Solicitor to proceed with negotiations with Myrtha Pools USA for the pool project, be adopted:

RESOLUTION 73-21

WHEREAS, Borough Council has determined and has financially provided for the construction improvements and other enhancements of our public swimming pool; and

WHEREAS, it is the intent of the Council to proceed as quickly and efficiently as possible to reasonably assure that the construction project be completed in time for opening of the 2022 summer season; and

WHEREAS, it is apparent to Borough Council and Administration that consideration of a construction quote and proposal from Myrtha Pools USA, Inc. (the company who has previously done major construction to the pool in 2003), is in the best interest of Quakertown Borough; then be it

RESOLVED, that the Borough Manager and Solicitor are authorized to proceed with the necessary contractual negotiations with Myrtha Pools USA, Inc. thus reflecting the intention of Borough Council to proceed with construction of the swimming pool as per the quote offered by Myrtha, which is not to exceed \$350,000.00, and further

RESOLVED, that the Borough Manager and Solicitor are also authorized to postpone any immediate action with the Myrtha Pools USA, Inc. should desired terms not be attained.

A motion was made by Vice President Roberts, seconded by Councilman Johnson. A roll call vote was taken and the motion was unanimously carried.

Councilman Wilsey agrees it is uncomfortable for Council to have a pool that is closed and totally inactive.

Councilwoman Wear also expressed the sooner the project can start it will save money because of the rise in building supplies.

WHEREAS, in 2021 it is estimated that 15,590 children and adolescents ages 0 to 19 will be diagnosed with cancer and 1,780 will die of the disease in the United States; and

WHEREAS, the causes of childhood cancer are largely unknown, research has advanced its successful treatment and improved the quality of life for children coping with cancer and the side-effects

of treatment, although five year survival rates have increased dramatically for some forms of childhood cancer, one out of eight children diagnosed with cancer does not survive; and

WHEREAS, the toll cancer takes on a child and family is unimaginable; a pediatric patient's expectations of a healthy, normal life, education and growth may be put on hold while parents must cope with high treatment costs, stress and the difficulties associated with caring for their family while being with their child for treatment, often having to travel or relocate to do so; and
