Councilman Johnson indicated that Mr. Biddle could speak at this time. Mr. Biddle gave some background and preview of what will be coming in the near future on the feasibility study for bus transportation in Upper

Bucks County. The Borough Manager replied that the Borough has been involved in the process for the last several years and is aware of the planning of future Upper Bucks public transportation. There is talk about a custom service which would be curb side, like an Uber service with an app. The cost would be somewhat expensive. There is discussion and still in the research stage to offer a local route similar to DART in Doylestown. Approximately four years ago meetings were held with SEPTA to see if they were interested in running a line from Montgomeryville to Perkasie and then further running it to Quakertown so commuters could access the Colmar train station. SEPTA's position at that time was that they needed more ridership data. The data since shows that ridership is weak and discussion is to see if this service would be justifiable at this point, weighing out the expenses vs. the revenues. The research is being done by the Bucks County Planning Commission Transportation Committee. The Manager stated local transportation is important to the Borough and are directly involved with discussions. As things unfold, updates will be brought to Borough Council to educate. The Borough Manager stated what he has learned through this process is public transportation is not sustainable so it has to be funded, the revenues do not meet the expenses and therefore most transportation is heavily subsidized which is going to be the biggest hurdle.

### **PUBLIC UTILITIES COMMITTEE**

President Rosenberger stated for Councilman Wilsey that there are not any items under the Public Utilities Committee.

### **PUBLIC WORKS COMMITTEE**

Councilwomen Wear stated that there are not any items under the Public Works Committee.

Councilwomen Wear asked if there was any information on the condemned property on East Broad Street. Manager McElree stated the Code Officer did condemn the house which is in the front of the property, the rear portion is not condemned yet. Violation notices have been issued and the Code Officer will be working with the property owner to continue to make sure that everything that needs to be done is being done. The Department of Aging has been contacted to see if the owner needs food and to see if he is well.
