WHEREAS, public works professionals focus on infrastructure, facilities, emergency management and services that are of vital importance to sustainable and resilient communities and the public health, high quality of life and well-being of the people of the Borough of Quakertown; and

NOW, THEREFORE, BE IT RESOLVED, That, the Council of the Borough of Quakertown wishes to accept Mease Engineering's Cedar Grove Park proposal dated April 11, 2022 for the amount totaling \$7,655.00 and authorizes the Borough Manager to execute the said proposal on behalf of the Borough of Quakertown.

Motion of Councilman Propst, seconded by Vice President Roberts. A roll call vote was taken and the motion was unanimously carried.

Councilman Propst indicated that Mr. Biddle could speak at this time. Mr. Biddle suggested some revisions to the License Agreement such as including the address for the Borough and The Drop.

RESOLVED, That, the following Resolution 51-22, approving the DROP License Agreement, be adopted:

## **RESOLUTION 51-22**

WHEREAS, a License Agreement has been prepared with the Quakertown Community Center, a non-profit organization who has established an initiative called The Drop which operates out of the Borough's Skate Shelter located within Quakertown Borough Memorial Park, to establish and provide guidelines and procedures; and

WHEREAS, The Drop is a youth assistance program geared toward middle and high school students who may find themselves adrift and faced with the temptation to cross into risky behaviors after school lets out.

NOW, THEREFORE, BE IT RESOLVED, That, the Borough Council of the Borough of Quakertown directs the Borough Manager to sign the Agreement upon receipt of the signed License Agreement from the Quakertown Community Center.

Motion of Councilman Propst, seconded by Councilman Wilsey.

Solicitor Nelson asked if The Drop has signed the Agreement yet. Manager McElree indicated that the Agreement has not been signed. Solicitor Nelson pointed out that tonights presented Agreement is different than the updated revised Agreement which he has at his office.

A motion was made by Vice President Roberts, seconded by Councilman Wilsey to table Resolution 51-22.

RESOLVED, That, the following Resolution 48-22, cost increase for swimming pool project, be adopted:

## **RESOLUTION 48-22**

WHEREAS, the Council of the Borough of Quakertown passed Resolution 100-21 on September 14, 2021, in which Council gave authority to the Borough Manager to proceed with Phase Two of the swimming pool revitalization project, with the proviso that the project would not exceed \$2,000,000.00; and

WHEREAS, the Borough Manager has been advised by Ray Palmer Associates, Inc. that we should anticipate some cost increases due to various materials and features changes; and

WHEREAS, the Manager anticipates that these costs may increase by as much as \$80,000 to \$100,000.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Borough of Quakertown that the Borough Manager be authorized to proceed with completion of Phase Two of the Swimming Pool Project at a cost not to exceed \$2,200,000.00.

Motion of Councilman Propst, seconded by Councilman Sell. A roll call vote was taken and the motion was unanimously carried.

RESOLVED, That, the following Resolution 52-22, Historical Society's request to replace a sign at Liberty Hall, be adopted:

## **RESOLUTION 52-22**

WHEREAS, the Quakertown Historical Society (QHS) has approached Borough Council regarding the concept of a historical marker to be placed at Liberty Hall; and

WHEREAS, the Quakertown Historical Society is seeking support for their application to the Pennsylvania Historical and Museum Commission for this project.

RESOLVED, that the Borough Council of the Borough of Quakertown supports the Historical Society's concept of erecting a historical marker at Liberty Hall and directs the Borough Manager to remain in contact with the Historical Society through project completion.
