Councilman Propst indicated that Mr. Direnzo could speak at this time. Mr. Direnzo explained that the shower in the men's locker room at the pool is broken. Manager McElree replied that he would have Public Works take a look at the men's shower, as well as, the ladies shower.

Councilman Propst announced there were 632 pancake breakfasts served at Community Day, and tomorrow night is the Pat Benatar concert and Friday is the Scotty McCreery concert.

President Rosenberger mentioned he will be sending a letter to the Community Day Committee on behalf of Council thanking them for their work with Community Day and their donation of \$30,000 towards the future park pavilion. On June 17, 2022 the QuiNBy Playground officially opened and has been a great success.
