Members of Quakertown Alive! were present to deliver two checks to the Borough. One was a \$300.00 donation for Shop With A Cop and the other was a check from the 50/50 raffles from the summer concert series in the amount of \$4,700.00. Jann Paulovitz mentioned Quakertown Alive! will be holding the Pumpkin Ball in April, 2023 at the Pearl Buck House and the Brewfest in August, 2023. Jann thanked Council for their support and her volunteers.

Robert Cormack, member of the Bucks County Economic Development Corporation and also represents the Quakertown Area Industrial Development Authority, was present to give a check to the Borough in the amount of \$23,268.95 from a project which settled in Bristol Township for the amount of 7.9 million dollars. Mr. Cormack stated the check represents a 30% closing fee from that settlement.

Councilman Wilsey stated he feels the No Turn On Red going westbound on Park Avenue at Main Street should be eliminated since the site distance is over a block long.

Motion of Vice President Roberts, seconded by Councilman Wilsey. A roll call vote was taken and the motion was unanimously carried.

RESOLVED, That the reading of Ordinance 1240, establishing the tax rate on real estate within the Borough for the fiscal year 2023 be waived. Motion of Vice President Roberts, seconded by Councilman Johnson. A roll call vote was taken and the motion was unanimously passed to waive the reading. Motion by Vice President Roberts, seconded by Councilman Sell for Ordinance 1240 to be passed finally. A roll call vote was taken and the motion was unanimously carried.

RESOLVED, That, the following Resolution 88-22, Act 57 of 2022- Effect of Failure to Receive Tax Notice, be adopted:

RESOLUTION NO. 88-22

A RESOLUTION OF BOROUGH COUNCIL OF QUAKERTOWN BOROUGH, BUCKS COUNTY, PENNSYLVANIA, REQUIRING THE ELECTED TAX COLLECTOR TO WAIVE ADDITIONAL CHARGES FOR REAL ESTATE TAXES WHERE NOTICE OF THE REAL ESTATE TAXES WAS NOT RECEIVED FOLLOWING THE TRANSFER OF REAL PROPERTY

WHEREAS, Pennsylvania Act 57 of 2022 ("Act") requires municipalities to adopt a resolution or ordinance requiring their respective elected tax collectors to waive additional charges for real estate taxes under certain circumstances beginning in the first tax year after the effective date of the Act; and

WHEREAS, Quakertown Borough Council, by Resolution, hereby requires the Borough Tax Collector to waive Additional Charges for real estate taxes following the transfer of real property where such taxes were not received.

NOW, THEREFORE, be it hereby RESOLVED that

- 1. The Tax Collector shall waive Additional Charges for real estate taxes in the then current tax year, if the taxpayer does all of the following:
 - A. Provides a waiver request of Additional Charges to the Tax Collector in possession of the claim within twelve (12) months of a Qualifying Event;
 - B. Attests that a notice of taxes owned was not received;
 - C. Provides the Tax Collector in possession of the claim with any one of the following:
 - i. A copy of the deed showing the date of real property transfer; or
 - ii. A copy of the title following the acquisition of a mobile or manufactured home subject to taxation as real estate showing the date of issuance or a copy of an executed lease agreement between the owner of a mobile or manufactured home and the owner of a parcel of land on which the mobile or manufactured home will be situated showing the date the lease commences; and
 - D. Pays the face value amount of the tax notice for the real estate tax with the waiver request.
- 2. A form providing for the waiver of Additional Charges will be made available from the Tax Collector and at Quakertown Borough Hall.
- 3. The taxpayer granted a waiver and paying real estate tax as provided in this Resolution shall not be subject to an action at law or in equity for an Additional Charge, and any claim existing or lien filed for an Additional Charge shall be deemed satisfied.
- 4. The Tax Collector accepting a waiver and payment in good faith in accordance with this Resolution and the Act shall not be personally liable for any amount due or arising from the real estate tax that is subject in the waiver.
- 5. As used in this Resolution, the following words and phrases shall have the following meanings given to them unless the context clearly indicates otherwise:

ADDITIONAL CHARGE – Any interest, fee, penalty, or charge accruing to and in excess of the face amount of the real estate tax as provided in the real estate tax notice.

QUALIFYING EVENT – For the purposes of real property, the date of transfer of ownership. For the purposes of manufactured or mobile homes, the date of transfer of ownership or the date a lease agreement commences for the original location or relocation of a mobile or manufactured home on a parcel of land not owned by the owner of the mobile or manufactured home. The term does not include the renewal of a lease for the same location.

TAX COLLECTOR – A tax collector as defined in Section 2 of the Local Tax Collection Law (72 P.S. §5511.1, *et seq.*); a delinquent tax collector as provided in Section 26.1 of the Local Tax Collection Law; the County Tax Claim Bureau or an alternative collector of taxes as provided in the Real Estate Tax Sale Law (72 P.S. §5860.101, *et seq.*); an employee, agent, or assignee authorized to collect the tax; a purchaser of claim for the tax; or any other person authorized by law or contract to secure collection of, or take any action at law or in equity against, the person or property of the taxpayer for the real estate tax or amounts, liens, or claims derived from said tax.

Motion of Vice President Roberts, seconded by Councilman Sell. A roll call vote was taken and the motion was unanimously carried.

WHEREAS, Quakertown Borough's portion of the household hazardous waste disposal costs would be \$1,429.97 year 2022, \$1,500.59 year 2023, \$1,765.40 for years 2024 and 2025.

NOW, THEREFORE, BE IT RESOLVED, That, the Council of the Borough of Quakertown agrees to participate in the Household Hazardous Waste Collection/Recycling program with the listed yearly contributions for years 2022-2025 and authorizes the Borough Manager to sign the Municipal Commitment Form.
