Motion of Councilman Propst, seconded by Councilman Johnson. A roll call vote was taken and the motion was unanimously carried.

Doug Wilhelm gave an update on various Borough projects. A paving project which is currently out for bid and will be getting started soon includes the Borough Hall parking lot, an ADA pathway in Memorial Park at Quinby's playground down to the pavilions and to the Community Day building. A paved roadway will be installed from the 9<sup>th</sup> Street baseball fields running to the football and soccer field lots. Manager McElree added that traffic calming will have to be added to the roadway.

The reconstruction of the Memorial Park Baseball Stadium is currently out to bid and has been extended one week due to electrical questions which needed to be resolved.

New low voltage lights which change colors have been installed outside of Borough Hall. New landscaping was installed out front of Borough Hall. The Police Memorial Statue was installed out front Borough Hall and a plaque will be placed.

A new American flag donated by Dave Gerstenberg Tree Service was installed near the amphitheater and Dave Yates supplied all the electrical work and donated all the lighting on the flag.

The bid for the new Maintenance Building Garage Roof was awarded several months ago and all the materials are on the roof along with the new HVAC system. Construction will start on April 17, 2023.

The Skate Shelter received new doors, windows and an epoxy floor and the inside was renovated and painted, bathrooms were updated and fireplace cleaned. Eventually the Skate Shelter will be available for the public to rent out or hold meetings.

The shade structures have arrived and one structure provided by Quakertown Alive! has been placed at a rest area at 4<sup>th</sup> & Mill Streets. Several shade structures have been installed around Quinbys playground. Six shade structures will be installed around the swimming pool.

The splash pad is now finished at the swimming pool. The sliding board is installed and April 22<sup>nd</sup> it will be tested out.

The trailer used as a dressing room received a new deck outside and the inside walls have been refinished and painted. The flooring will be worked on next week and a kitchenette will be installed.

Pavers and benches have been installed at Freedom Park and the Historical Society sign will be placed there.

The pavers installed at these various projects were refurbished from the War Memorial.

The concrete has been poured and wood and trusses ordered for the new pavilion in the Park at 4th.

Manager McElree stated most of these projects have come under budget.

Council commended and thanked Mr. Wilhelm for handling this extra responsibility in addition to the Code Office responsibilities.

Manager/Chief McElree announced that Police interviews for Council will be the week of April 17, 2023.

President Rosenberger declared the meeting adjourned at 8:42 p.m.
