Code Officer Wilhelm stated under the Zoning Ordinance, Accessory Uses, "keeping of animals or fowl", the distance of any building housing fowl would have to be made less than 100 feet of any lot line. Currently the Ordinance reads fowl must be housed in a building at least 100 feet from any lot line. Also Mr. Wilhelm mentioned no roosters permitted should be added to the Ordinance, as well as, lessening the amount of chickens permitted.
