WHEREAS, the Borough of Quakertown acknowledges the requirements of Section 322 of DMA 2000 to have an approved Hazard Mitigation Plan as a prerequisite to receiving post-disaster Hazard Mitigation Grant Program funds; and

WHEREAS, the Bucks County 2011 Hazard Mitigation Plan has been developed by the Bucks County Emergency Management Agency and the Bucks County Planning Commission in cooperation with other county departments, and officials and citizens of the Borough of Quakertown; and

WHEREAS, a public involvement process consistent with the requirements of DMA 2000 was conducted to develop the Bucks County 2011 Hazard Mitigation Plan; and

WHEREAS, the Bucks County 2011 Hazard Mitigation Plan recommends mitigation activities that will reduce losses to life and property affected by both natural and human-made hazards and face the County and its municipal governments.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council for the Borough of Quakertown

- The Bucks County 2011 Hazard Mitigation Plan is hereby adopted as the official Hazard Mitigation Plan of the Borough of Quakertown; and
- The respective officials and agencies in the implementation strategy of the Bucks County 2011 Hazard Mitigation Plan are hereby directed to implement the recommended activities assigned to them

Motion of Councilman Scholl, seconded by Councilman Rosenberger. A roll call vote was taken and the motion was unanimously carried.

RESOLVED, That, the following Resolution 20-12, Economic Development Proposal, be adopted:

WHEREAS, the Borough has received a proposal for an Economic Development Parnership for the Revitalization of Quakertown from the Bucks County Economic

Development Corporation and the Upper Bucks Chamber of Commerce.

NOW, THEREFORE, BE IT RESOLVED, That, the Council of the Borough of Quakertown wishes to accept the Economic Development Partnership for the Revitalization of Quakertown proposal of Bucks County Economic Development Corporation and the Upper Bucks Chamber of Commerce, as per their proposal dated January 20, 2012, at a cost of \$40,000.00.
