Jann Paulovitz gave a presentation on Quakertown Alive! accomplishments and goals, which included the following:

Arts Alive will be held on May 18, 2013. An activity added to this event is a wine tasting event in the Antique district on the East Broad Street location. Lynn Kraft is constructing a gateway at the railroad tracks. Bucks County trolley has committed to come to the event and take people from the downtown, up Broad Street to the Burgess Foulke House, the Chamber of Commerce, and McCoole's. This is the first year the entire town will be included in this event.

Garden Affairs will be held on June 30th. It includes six houses along with the Marketplace. Burgess Foulke house will be open with the Keystone Quilters displaying their quilts.

Upper Bucks Brewfest will be held August 17th at the Quakertown Train Station and will include six local restaurants.

Money from these events will help with the marketing of the town and continue with the help of keeping up with the planters, the hanging baskets and the park.

The kiosk is still in the planning stages. Quakertown Alive received a \$5,000 grant from First Niagara. Half of this money will go toward the kiosk.

\$249,000 has been awarded and Naomi will have the budget ready for the new antique lighting.

Quakertown Alive! and Quakertown Borough will meet with the Preservation Historic Museum Commission and this will provide the guidelines for the downtown improvements.

Assessment has been completed with the PDC and Quakertown Alive's accreditation was approved for the Keystone Community. This is one of the highest achievements for the Main Street program.

The Quakertown In-Town Guide will have an art theme and show the talents of the Upper Bucks artists.

Another campaign started is Love your Local Campaign. Quakertown Alive! has almost 30 businesses that have joined. Quakertown Alive! will help with their advertising and they would like to get a marketing committee together for this.

Quakertown Alive's vision statement will be revisited on the 22nd and they will be meeting with the majority of the directors at the Pennsylvania Downtown Center.

The Grand Opening and ribbon cutting ceremony for the new bakery, Moussey Moose, will be on Friday, March 8, at 9:00 a.m.
